# **Course Description**

The purpose of this course is to offer graduate students interested in computer network security an opportunity to become familiar with some important aspects of the field. This is a directed reading course so most learning will take place independently through a series of literature reviews. Content for reviews will be directed according to reports which must be submitted regularly. Suggested topics for review are delineated below but students are encouraged to submit other areas of interest:

Foundations in Computer Networks Common Security Attacks, Services and Mechanisms Encryption and Cryptography Communication Protocol Vulnerabilities Operating System and Web Application Vulnerabilities Wireless Protocol Vulnerabilities Security issues with respect to Database software, peer-to-peer networking, instant messaging, and network devices (routers, switches etc.)
